EEPROM testing

 This is where we test our EEPROM firmware requirements ensuring we can code to the various locations for platform compatibility.

Scope

Check that we did not receive parts already contaminated.

Transmitter Optical Power

 In this test, the power and wavelength of the laser is verified using a spectral analyzer.

Link

 This includes initial link along with link restoration on fiber pull and hard/soft reboot.

DDM

- Verify proper thresholds and live values for temperature, voltage, laser Bias, Tx
 Power, and Rx power.
- Receiver Sensitivity/BER
 - Test the minimum receive power that the transceiver will operate free from errors.
- Loop length dispersion testing
 - Loop Length Dispersion Testing measures a transceivers BER considering the impact of both dispersion and attenuation.
- 24-hour Traffic Test (EXFO)
 - Run 100% throughput over max specified fiber length.
- Receiver overload testing
 - o Test the maximum receive power that the transceiver will operate free from errors

- Verify laser turn on Laser turn on is typically used as a quick indicator of a transceivers base compatibility.
- Link and observe system for error free operation Errors consist of anomalies that severely impact a transceivers operation. Pivotal transceivers should never flag compatibility or third-party alarms. Things that may flag errors include:
 - I2C Communication Failures
 - Electrical and/or Pin Timing Issues
 - Code Issues resulting in host rejection and/or disabled interfaces
 - Critical deviations from optical or electrical operating specifications
 - Missing information compared to the OEM transceiver
- Verify Host Recognition Host recognition consists of determining if a part is recognized correctly. Successful recognition indicates a transceiver is communicating correctly with the host device. Parameters directly observed include:
 - Revision, Serial Number, OEM Part ID, CLEI, length, wavelength, vendor name, vendor part number, and additional compliances.
- Verify DDM
 - Transmit Power and Laser Bias
 - o Receive Power
 - Temperature
 - Voltage

We base our initial reviews on the primary standards which our manufacturers follow. This includes reviews of the manufacturer datasheets and DVT reports to ensure the product meets MSA/IEEE standards.

Work with the manufacturer to ensure their firmware for the EEPROM matches our needs since we do compatibility coding in-house.

Once parts are received, we perform lab testing for final approval.
